USER REPORT

Margaret Hillerby at Body in Tune Wellness Clinic has been using the complex Dianel Oberon 22 s ion model, Serial Number: 0080286, with the software Dianel Pro since purchasing it on the 27th March 2012.

I practice Scenar Therapy, bioresonance testing and energy healing, with a focus on pain relief with Scenar. I do not have a medical license. I mainly use the Dianel on my family and myself, plus a few clients, as my healing practice is only part time.

During the operation of Dianel Pro since June 2012 up to November 2016, approximately 52 patients were tested with the device. The disorders, which are most frequently detected with the help of the device, have been digestive, skin, cardiac, spine and some respiratory, hormonal and joint disorders. In many cases it was good to be able to confirm for clients that these areas were showing up as being out of balance, but not many were motivated to have a number of return visits for further treatment as they didn't necessarily understand the advantages of doing this. This is not a well-known technology in New Zealand.

I mainly use the device to ascertain areas of imbalance in our bodies associated with pain and discomfort and to compare medical diagnosis in a few cases. My husband had a hip replacement last year and it was great to be able to track his improvements and healing. He and I both have digestive issues and we have used the device to rebalance and track improvements in this area as well.

The advantages of working with a Dianel Complex are that you can see the imbalances and changes in the body in real time, and the remedies that can be used on the spot as well rather than having to get a prescription and get it filled somewhere else at more expense. Also it is helpful to be able to confirm for clients if they have allergies, heavy metal toxicity or are being effected by EMR that may be underlying causes of the disorders. It is a "one-stop shop"! This technology fits positively and effectively with my other healing modalities and gives clients the opportunity to take more control of their own healing.

I find the device to be mostly user-friendly, except for the slowness of the programme when doing the rebalancing stage – that is the time it takes to return to specific slides between rebalancing. However this is not a major issue and may be related to my computer.

If I attempt to do more than one modality in a session, eg Dianel plus Scenar, it can take too long and tire my clients so I now limit it to one or the other.

I do not find any real disadvantages or inconveniences in the complex or the software. I really enjoy using the device especially as I know that it is making a difference for my family and I and for a few clients who take advantage of it. I am looking forward to using it more in the future.
